AGREEMENT

On organizing joint paid services in medical specialties of "Mkhitar Gosh"

Armenian-Russian International University.

Yerevan

"Mkhitar Gosh" Armenian-Russian International University LLC (hereinafter referred to as the Customer), represented by the Executive Director, Ashokchandra Narsimbhai Patel and "DE VIE SAN" LLC which is the trust manager of the rights certified by the shares of Yerevan "Kanaker Zeytun Maternity Hospital" CJSC (hereinafter referred to as the Executor), in the person of the director Tachat Asaturyan, signed a contract for the provision of paid services.

1. Subject of the agreement

In the field of higher medical specialty - Obstetrics - gynecology, the organization of the educational process by the "Kanaker Zeytun Maternity Hospital" center, according to the curricula and subject programs ("General Medicine") presented by the University.

"Kanaker Zeytun Maternity Hospital", according to this agreement, is a base for organizing practical internships at "Mkhitar Gosh" Armenian-Russian International University.

2. General provisions

Mutually beneficial cooperation of the parties presupposes:

- 1. Conducting internships by the Contractor on the subject of the client's curriculum "Obstetrics Gynecology" in classrooms equipped with the necessary equipment.
- 2. The client is obliged to involve experienced doctors-specialists in the training courses. Define the following number of interns;

• 200 places each for the specialty "General Medicine"

3. Obligations of the parties

- 1. To set the cost of organizing the educational process for each academic year (each year from 1st September to July 31) to set 1,320,000 (one million three hundred and twenty thousand) AMD, including VAT.
 - 2. The customer makes the payment by the executor, based on the tax invoice.

4. Obligations of the executor

Introduce students to the rules of the Contracting Party, safety rules.

- 2. To give the right to the doctors with skilled and experienced, scientific titles (or) degrees presented by the University to teach in the center, as lecturers of relevant medical subjects or, as heads of departments.
- 3. Create the necessary conditions for the organization of the educational process.
- 3.1 To provide cabinets and laboratories for educational programs, equipped with the necessary teaching equipment, posters, diagrams, literature, in order to organize the educational process of students.
- 3.2 Provide students with subject curricula, practice labs equipped with the necessary equipment and photographs.
- 3.3 Use methodological instructions for mastering the topic during the lessons.
- 3.4 Develop and use the "laboratory passport" for laboratory audiences.
- 3.5 Adjust the classroom fund to students with disabilities.

- 3.6 Ensure that the number of students in the wards does not exceed the permissible norms.
- 3.7 Supervise what the students do at the "Kanaker Zeytun Maternity" Hospital, with what staff, who oversees their activities?
- 4. Coordinate all issues and changes related to the educational process with the University.

5. The rights of the parties

- 5.1 "Kanaker-Zeytun Maternity" Hospital has the right to terminate the contract early if "Mkhitar Gosh" Armenian-Russian International University uses the space in accordance with the contract or its significance.
- 5.2. "Mkhitar Gosh" Armenian-Russian International University has the right to demand from the "Kanaker-Zeytun Maternity" Hospital that the educational process be of proper quality.
- 5.3. Terminate the contract early if the "Kanaker Zeytun Maternity Hospital" does not fulfill the obligations stipulated by this agreement.

6. Final provisions

- 1. This Agreement shall enter into force on the date of its signing, shall be valid for an indefinite period.
- 2. 2. The contract is signed in 2 copies, one of which is with the Customer, the other with the Executor.
- 3. In case of additional conditions, a new contract is signed.

- 4. The contract may be terminated by agreement of the parties;
- 5. The contract may be terminated as a consequence
 - In case of declaring one of the parties bankrupt or force majeure (force majeure)
 - In the event of dissolution or reorganization of either party.
